RV ALTERATIONS AND VARIANCES

In an effort to maintain a consistent look and feel of our resort, guidelines have been established for what is permitted on individual lots. These guidelines benefit all of us, and all owners are encouraged to review the Community Rules & Regulations document and be familiar with the requirements.

Your Board of Directors recognizes that owners may wish to alter their RV property. Frequently, desired changes do not fall within the community rules, but may still be acceptable.

To provide owners with guidance on changes to their RV lot, the Board has created two new forms;

RV Alteration Application - complete and submit this form when your planned alterations fall within community guidelines. There is no application fee associated with this form.

RV Variance Application - complete and submit this form when your planned alteration does not fall within the community guidelines. Note that there is a \$25.00 fee associated with this form.

Please submit drawings and detailed explanations with the form, regardless of which you use. When completed, please submit to info@lakemcgregorreort.com and provide credit card payment, or drop off the completed form with a cheque payable to LMCECA. The Board will endeavour to provide responses to all applications within five weeks of receipt.

Copies of both forms are on the following pages. These are also posted to the resort's website in the "Documents" section of the "Members Only" area.

Water Turn On
